Network Protection: We use advanced firewalls, endpoint protection software and continuous monitoring to safeguard our internal systems and prevent unauthorized access.

Employee Training: All of our staff undergo regular cybersecurity training to recognize threats like phishing emails and suspicious activity. A strong first line of defense begins with informed people.

Customer Data Security: Any personal or billing information we collect is encrypted and stored securely. We follow best practices for data privacy and comply with applicable regulations.

Multi-Factor Authentication (MFA): All administrative and remote access accounts are protected with MFA. Compromised credentials can be safeguarded with MFA


Co-op attended the fair.

Wheat Belt Public Power District is pleased to recognize the recent accomplishments of board members Toni Blomenkamp and Marcus Milanuk, who have completed advanced certifications through the National Rural Electric Cooperative Association (NRECA).

Blomenkamp earned the Board Leadership Certificate (BLC), which builds on the foundational Credentialed Cooperative Director program and includes 10 credits of advanced coursework focused on cooperative governance and industry issues.

Milanuk attained the Director Gold Credential (DGC)—the highest level of NRECA board certification. This credential signifies an ongoing commitment to education, requiring continued coursework every two years to maintain status.

As the electric utility landscape grows more complex, these certifications ensure that Wheat Belt PPD board members are equipped with the knowledge and skills necessary to guide the organization with insight, integrity and a strong commitment to cooperative and public power principles.

- Board reviewed and amended Policies: D-15, Conflicts of Interest; C-9, Disconnect for Non-Payment; O-5, After Hours Connections or Disconnects and F-3, Investments. Updated customer policies have been uploaded to Wheat Belt PPD's website.
